Galileo Japan Trust (ASX:GJT) Request to lift Voluntary Suspension

On 27 February 2009 GJT requested a voluntary suspension of trading. GJT now requests that the suspension cease and that trading recommence today Monday 2 March 2009.

The two matters referred to in GJT's suspension request have now been dealt with.

The half year results to 31 December 2008 have now been lodged with ASX.

The notice received from the Japanese lender on the evening of 24 February 2009 has now been clarified, as noted below.

The Japanese lender notified GJFML on 24 February 2009 that appraisals sought by the lender had been finalised. The potential impact of the appraisals on the loan to value tests is set out in the Half-Year Results Announcement and Appendix 4D and Accounts - 31 December 2008 lodged today.
